NOTICE OF RACE

1. PARTICIPATION

Category admitted to enter : **DRAGON**

2. ORGANISATION

With the patronage of the Association Française de la Série Internationale des Dragon (**A.F.S.I.D.**), and under the aegis of the Fédération Française de Voile, the Société Nautique de la Trinité-sur-Mer is organising the racing of

the « DRAGON de La Trinité - TOSHIBA Trophy » from 19th to 23rd June 2007.

3. RULES

- a) Racing is governed by the rules as defined in the Racing Rules of Sailing (RRS) 2005-2008, the FFV prescriptions (in particular compulsory permits), the current International Dragon Class Rules, this Notice of Race and the Sailing Instructions (including their appendices and amendments).
- b) This shall be a Category A event (under ISAF Advertising Code regulation 20).
- c) French competitors must be up to date with their A.F.S.I.D. 2007 subscriptions.
- d) Overseas competitors shall hold current equivalent to the French sailing permit, or an insurance certificate confirming third party liability cover for up to 1.5 million euros, together with a medical certificate indicating that there is no known medical reason preventing the holder from sailing. In the event of no or inadequate insurance cover, they can take out a third party liability policy at little cost with the club organising the event.

4. ENTRIES

- a) Entry fees are as follows :
 - entry fee : **300 €**
 - launch fee: included
 - hauling out fee : included
 - dinners included for crew – guests : 20 € on 21 & 22 June
- b) Return the attached entry form as soon as possible together with your payment (which will be cashed / debited one month before the event) to **Société Nautique de La Trinité BP 19 – 56470 La Trinité / Mer**
- c) On location, during the entry confirmation process, the following information and documents will be required :
 - Crew list (with sailing permits and medical stamps / certificates)
 - Measurement certificate
 - Boat insurance documents

5. COMPETITORS LIABILITY

Responsibility for the decision to race or to continue racing shall be made by the skipper alone.

Skippers shall be personally liable for any personal injury and damage to sustain to their boat, property or crew. They have to take out adequate insurance to cover this liability.

With the regard to the application and interpretation of the documents set out in paragraph 3 of this Notice of Race and any disputes arising under its provisions, entering the boat implies waiving the right to redress other than provided under the RRS.

6. SCORING

- Low Point Scoring System as provided in the RRS (appendix A) shall apply. The Overall Scores shall be calculated by excluding the worst result if at least four races are run and validated. If 8 (or more) races are run and validated, the two worst results are excluded in calculating the overall score.
- A special scoring will be done for traditional wooden hull units if a minimum of 5 boats have entered
- A maximum of 10 races are scheduled and the Championship will be validated if at least 3 races are run and validated.

7. BERTHS

Competitors shall have access to berths in the marina free of charge from 18th to 24th June. If you wish to book a berth before or after these dates, please contact the harbour office directly.
